If your dog passes our initial assessment and is accepted into our daycare program, there will be a 90 day probationary period where our daycare attendants will closely monitor your dog's behavior. During that period we will be closely communicating with you about their progress. If at any time the daycare staff deems your dog unfit for our daycare program we hold the right to terminate them from the program.

Bite Policy

This policy applies to all dogs participating in daycare. This policy is designed to create a safe and harmonious environment to all dogs participating in the daycare program and ensure the safety of all attendants.

Procedure:

If a dog inappropriately bites another dog, an attendant, or any other employee at Muddy Creek, in a dominant or aggressive manner and inflicts any type of injury to them, the attendant holds the right to terminate the dog from the program. Owner will be notified of the incident immediately.

Please be aware of the inherent risks of dogs interacting in a social play group setting. These risks include but are not limited to:

- infectious diseases
- minor traumas
- cuts and abrasions
- bite wounds

Should your pet require veterinary care to address any medical issues from participating in this program, you will assume financial responsibility for your pet.

Spay and Neuter Policy

Muddy Creek Animal Care Center recommends that all dogs be spayed or neutered between 6-8 months of age. To ensure appropriate behavior and safety in daycare, all dogs must be spayed or neutered by 8 months of age. If a dog is exhibiting inappropriate behavior prior to be spayed or neutered while they are under 8 months of age, it will be determined on an individual basis if the dog is allowed to continue to partake in daycare by the daycare team. Any dog over 8 months of age that is not spayed or neutered may not attend our daycare program.

Monthly Requirement

For your dog to stay in the daycare program they must come to daycare at least once a month. This is because the groups are constantly changing and new dogs come in frequently that we need to ensure your dog gets along with. If you would like your dog to participate in Daycare while boarding, they must come outside of boarding on a regular basis as well. During Daycare while boarding the Daycare Attendant holds the choice on having your dog

skip a day if they think they have been doing too many days in a row which may cause them to be exhausted or overstimulated.

Vaccine Requirements

Your dog must be up to date on the following vaccines to participate in daycare: Rabies, Parvo/Distemper, Kennel Cough (Bordetella), Influenza (At least the 1st part of the series) and a negative fecal sample. The vaccines must be given 5 days prior to coming to daycare if overdue or not given yet.

Microchip Requirement

All dogs participating in daycare at Muddy Creek must be microchipped. This is to ensure the safety of all the dogs participating in group daycare.
